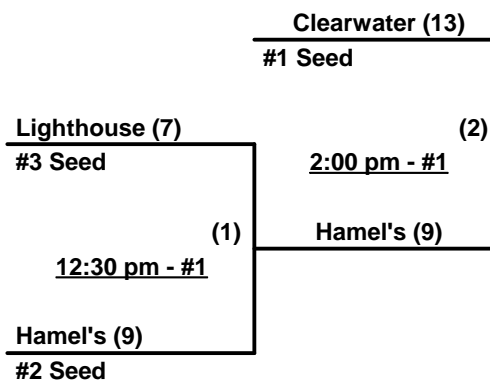

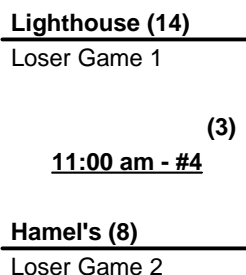

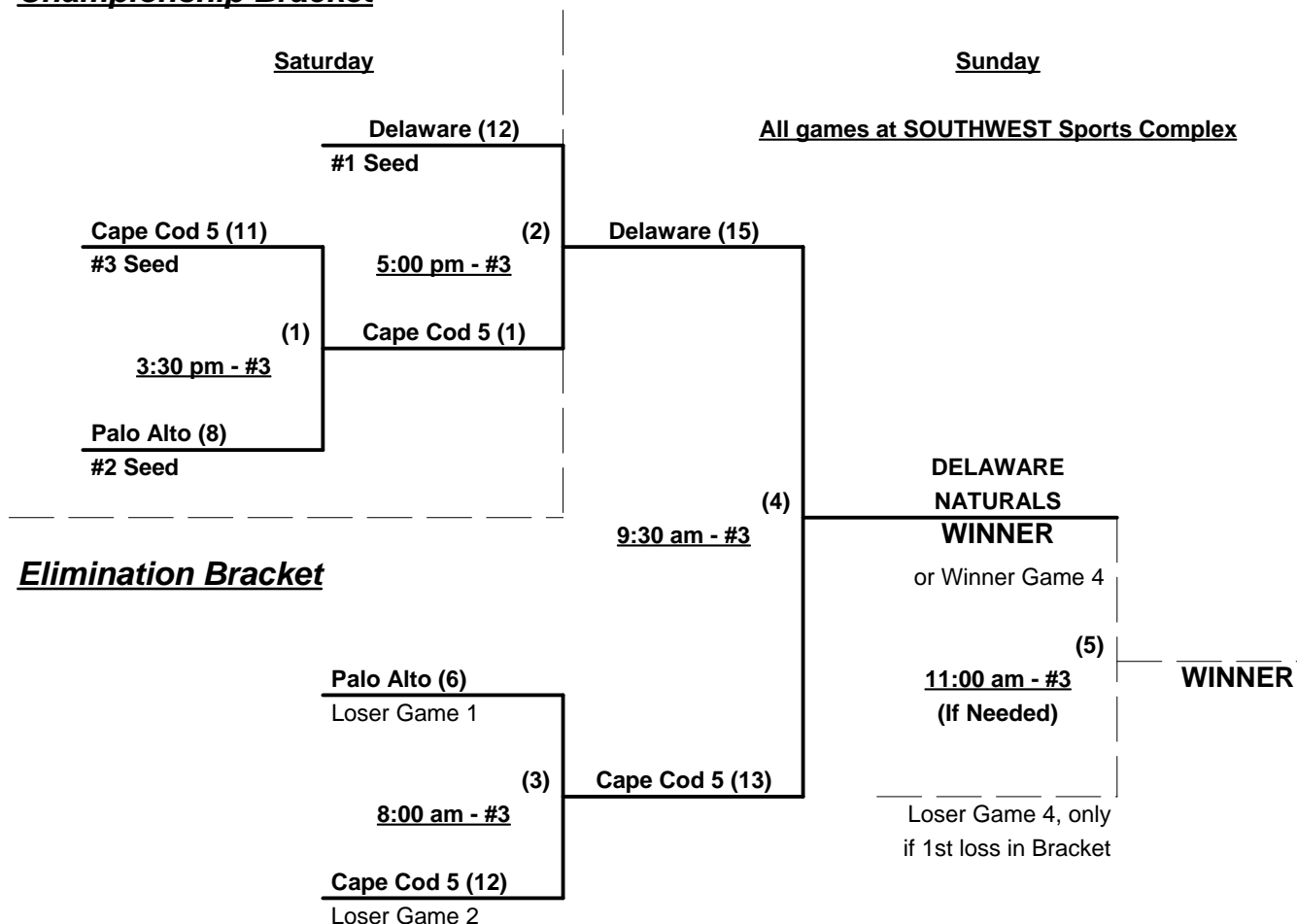

Elimination Bracket



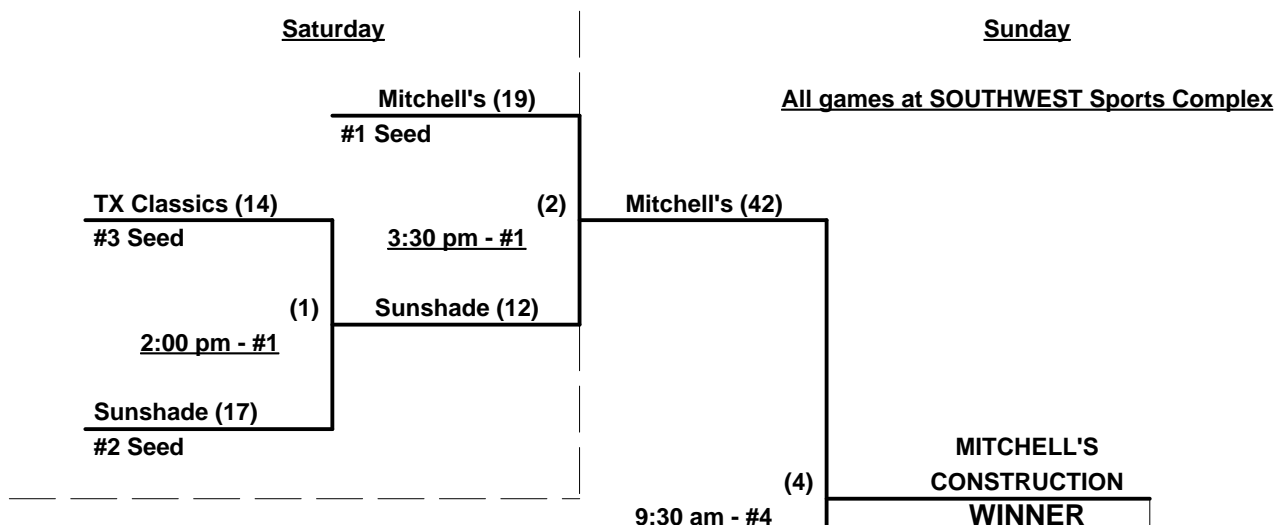

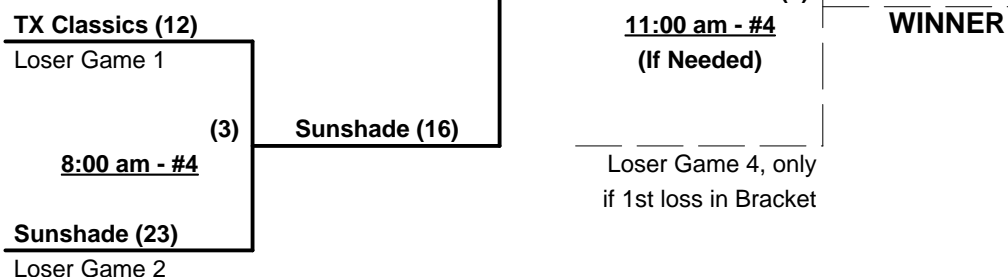

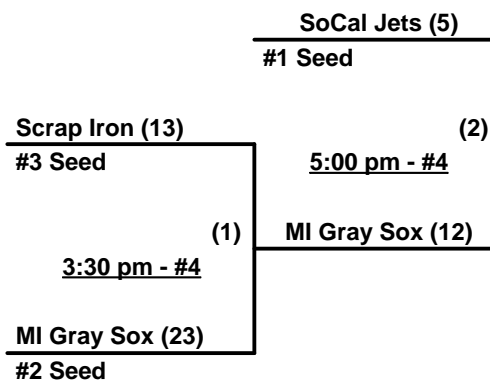
