Mercy Rule - Fifteen (15) Runs after five (5) innings (or 20 runs after 4 innings)

Time Limits - RR = 65 + open inn. • Bracket = 70 + open inn. • Championship game(s) = 80 + open inn.

Tie Breakers - Head to head (in full RR only), least runs allowed, run differential, coin toss

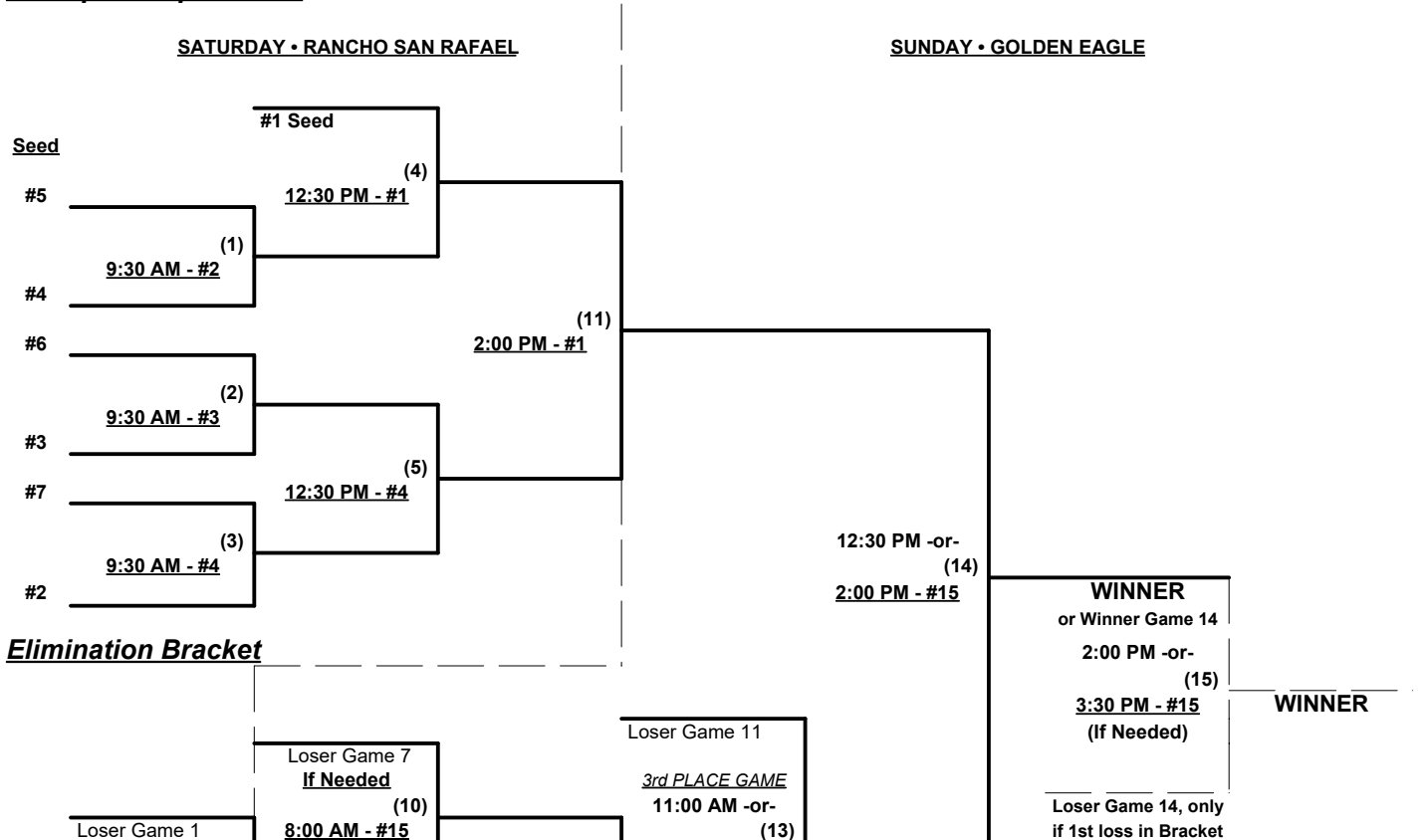

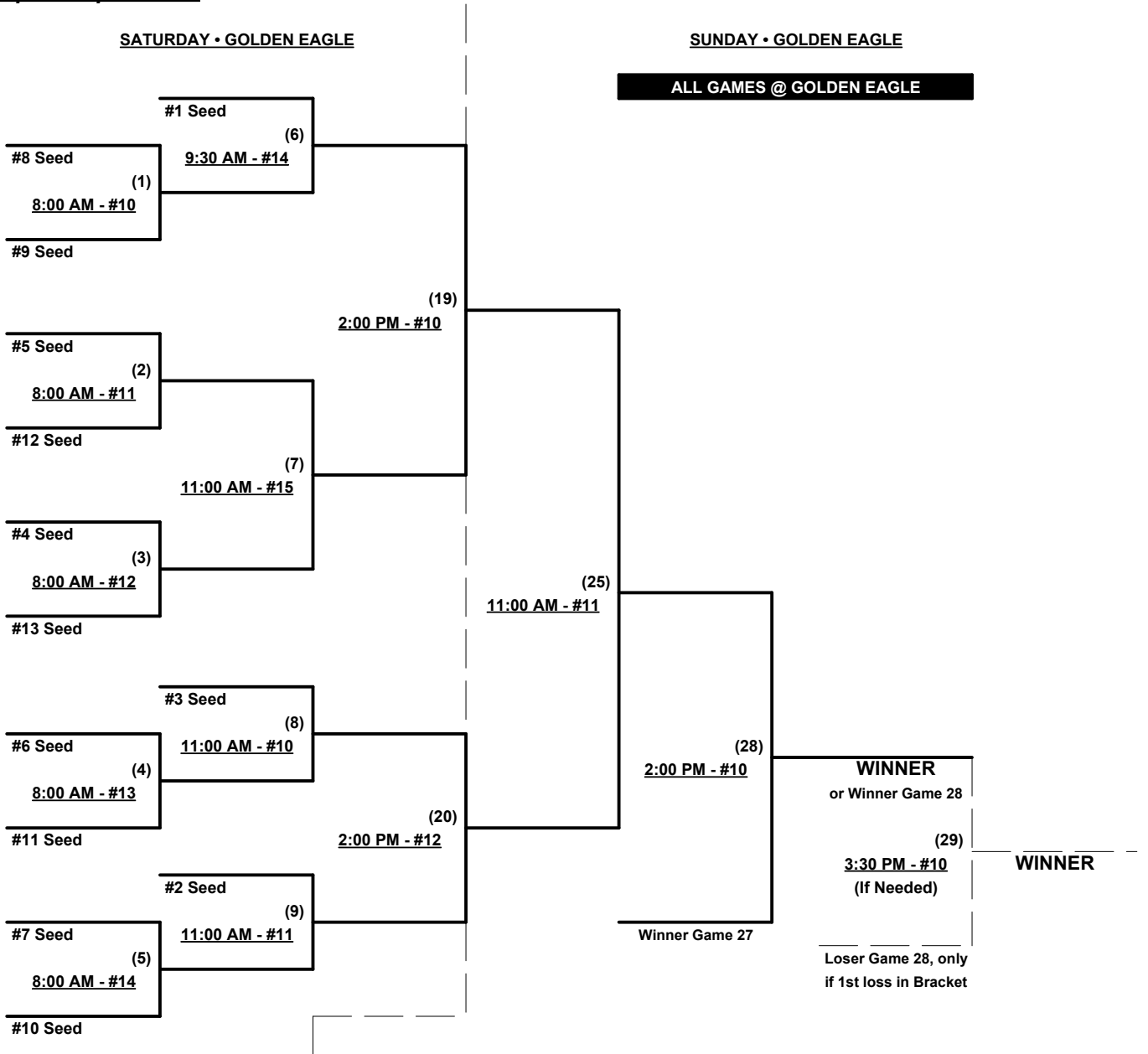
