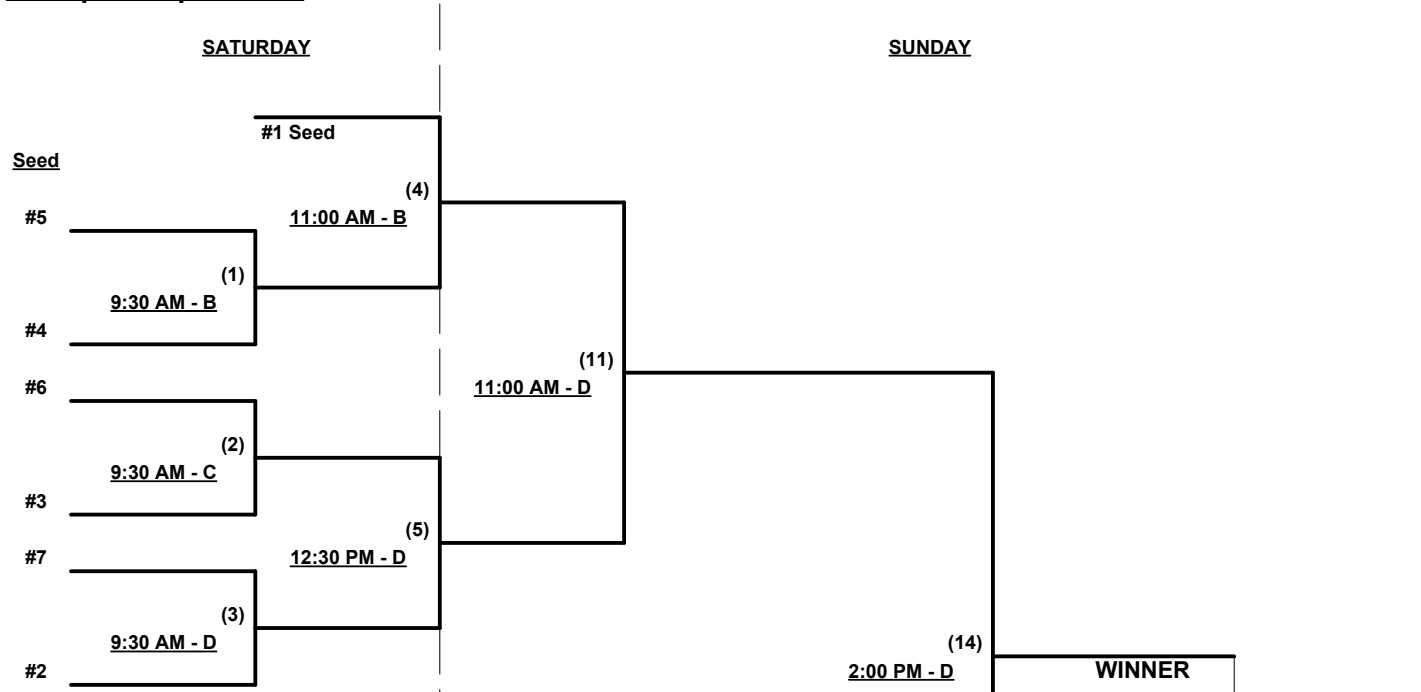

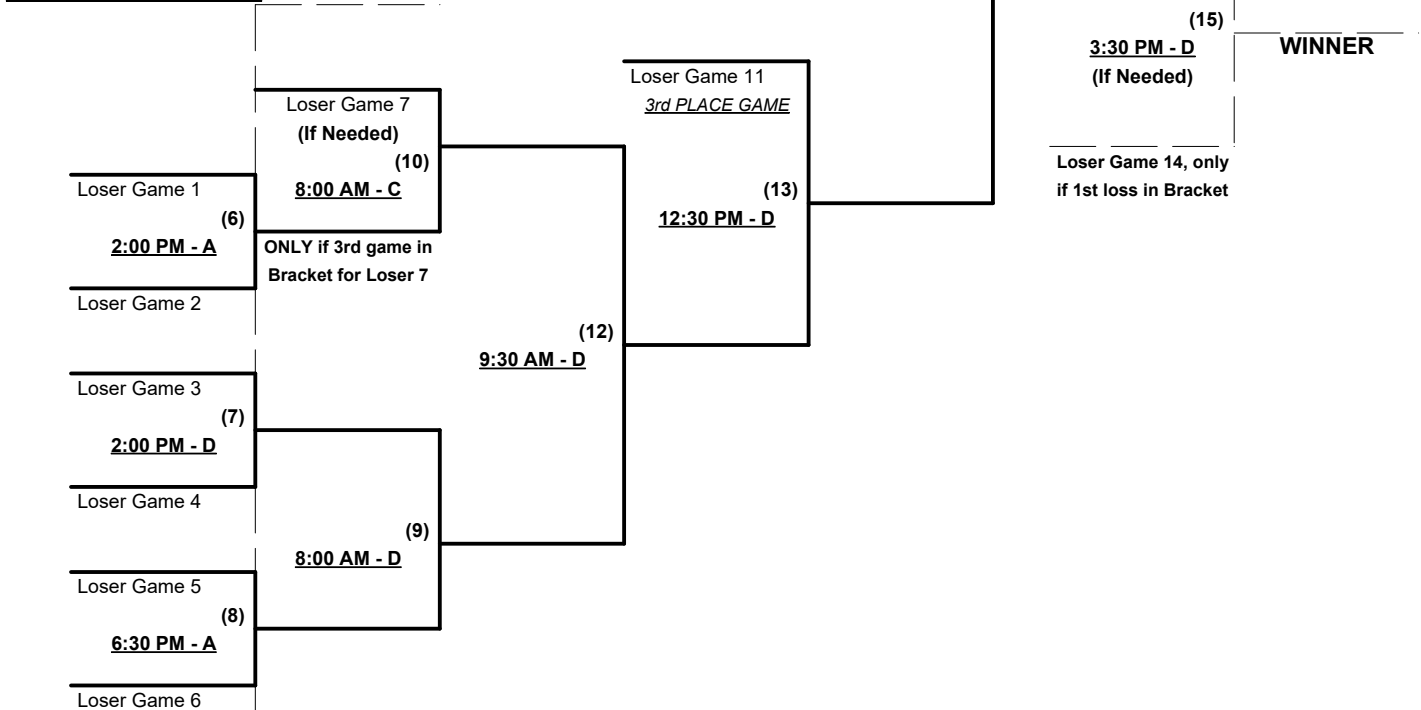

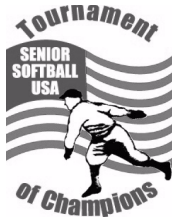

Elimination Bracket





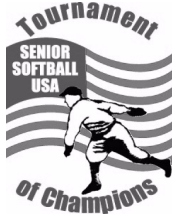
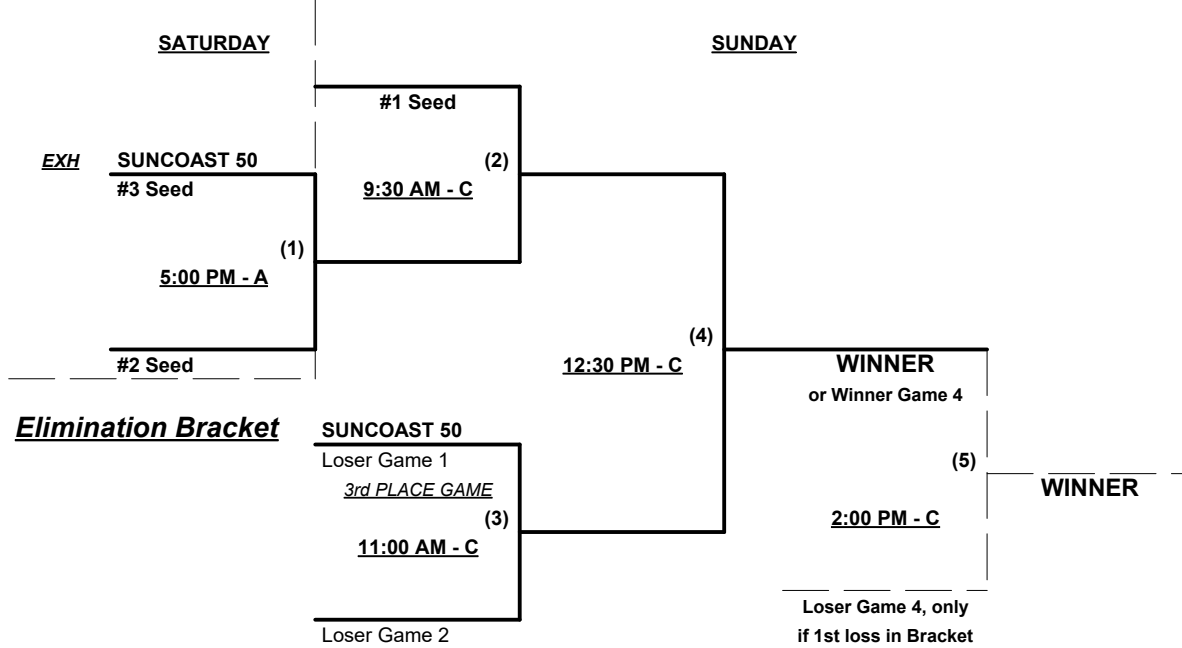

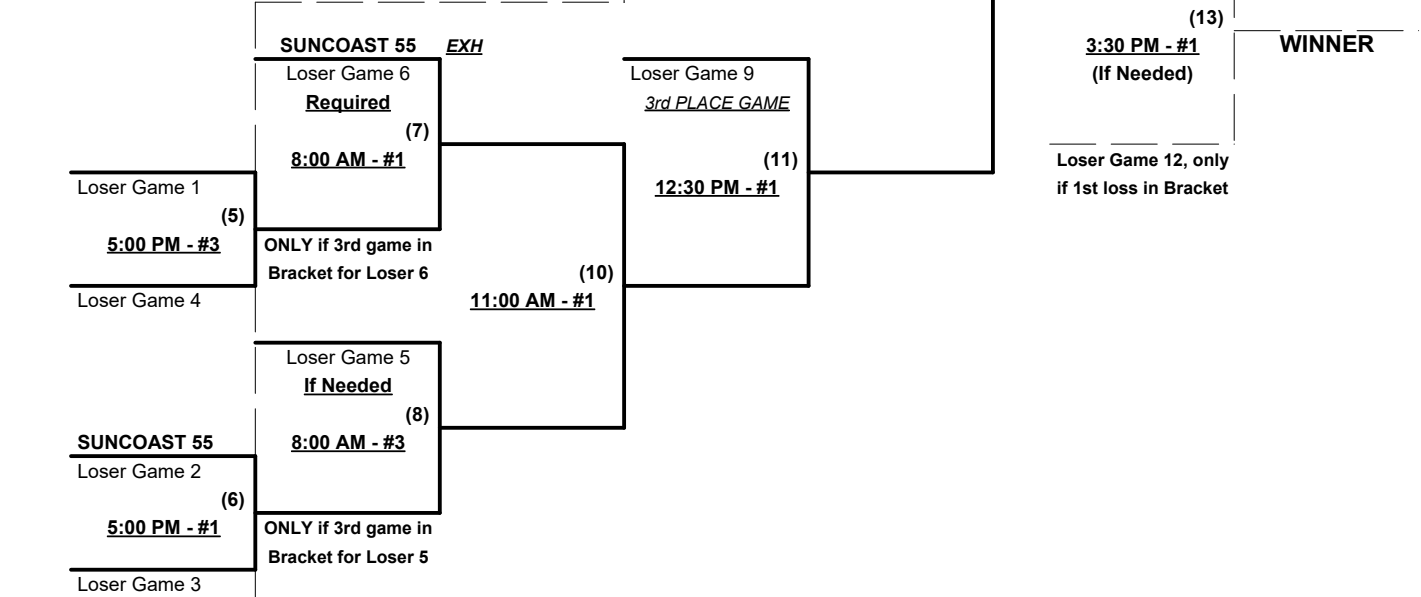
